Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[Note: This claimant does not include a claim for military service. The provisions for which the claimant seeks reimbursement, however, resulted in a receipt or receipts which contain important information as to troop movements, locations and/or timing. Although its failure to include a claim for military service would ordinarily exclude this claim from inclusion in this database, it is thought that the information contained in one or more receipts is worthy of inclusion in our database.]

To the Honorable David Ramsey Esquire President & the Honorable members of the Senate

The Humble Petition of Benjamin Hicks Sheweth

That on the 10<sup>th</sup> day of January in the year of our Lord 1781, Major James Wall of the State of Virginia was employed to Remove the Records of this State from The Reverend William Fanning, of Greensville County To Barkley County, in the State of Virginia. That the said James Wall employed two waggons Teams & Drivers of your Petitioner to assist in removing the said Records, that in the year of our Lord 1792 or 3 Major James Wall's Account including the amount of your Petitioner's account was passed into an Indent. That the said Major Wall is Dead as well as Colonel Edwin Gray & Colonel John Lucas, who were the Executors of the said Major Walls [sic], so that the said indent still Remains in the Treasurys of this State the said James Wall having no Legal Representative to Draw the same, whereby your Petitioner is prevented from obtaining his part or proportion of the same.

Your petitioner therefore most humble he prays that your Honorable House may direct the Treasury of this State to Deliver him an indent for the Amount of his Account Deducting the same from the Amount of the indent in the Name of Major James Wall, now lying in the

Treasury or grant your Petitioner such other Relief as from the Circumstance of the Case into your Honorable House shall seem meet.<sup>2</sup>

To the Honorable David Ramsey President, & the Honorable member of the Senate The Humble petition of Benjamin Hicks Sheweth

That on the 10<sup>th</sup> day of January in the year of our Lord 1781 Major James Wall of the State of Virginia was Employed by Mr. William Parker, who was then Treasurer of this State, to Remove the Records of South Carolina, from The Reverend William Fannings of Greensville County to Barkley County in the Said State of Virginia, That the said James Wall Employed two waggons teams and Drivers of your petitioner to Assist in Removing the said records, that in the year 1783 - the said James Wall applied to Col. James Mason & your petitioner to have our accounts included with the said Wall's & was Agreed to, which Account was sent By the said Wall, to Mr. William Parker, which Gentleman had promised to have that account Laid before the Assembly of the said State, when convened and by the Death of the said Parker & some other Circumstances that account was Laid Over & still remained in the Treasury of this State, until February 1791 – and then the account was brought forward & Laid before the Honorable Gentlemen of the Senate and the Honorable representatives of this State & Has been passed into an indent for the whole amount of said Wall's, Mason's & your petitioner's account. But by the misfortune of the Death of Major James Wall & both the said Wall's Executors, also Col. James Mason & his Executors, and no Administrator to the late James Wall's Estate [bottom of the page damaged and text rendered illegible]

Petitioner had been informed that the Honorable Henry Tazewell had or intended administering on the said Wall's Estate.

Your petitioner has made application to Mrs. Wall the widow of the late James Wall, & Mr. Tazewell twice by letter & once by his Son Benjamin Hicks and never have Received any Answer, only by his Son & then there was no Legal person to transact the said Wall's business. Therefore it gives your petitioner the greatest Reason to believe that there is no administrator to the said Wall's Estate yet, or they would have stepped forth and made application, or directed your petitioner to have drew [sic] the indent & made saile [sic] of it, & Sent the Cost [?] to the Right owners before this.

There being no administrator, which prevents your Petitioner from obtaining an order for his part of that account, and can't find out any way to recover it only by the Assistance of the Honorable Gentlemen of the Senate – and Representatives of This State –

Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.

Therefore your petitioner most humbly prays that your Honorable House may direct the commissioners of Publick accounts, to deliver your petitioner an Indent for the amount of his account here unto annexed, deducting the same from the index now Lying in the Treasury in the name of the late James Wall, or grant your petitioner such other Relief as from the circumstances of the case to your Honorable House shall seem meet, and your petitioner as in duty bound will ever Pray
