[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The petition of John Hicks Humbly Sheweth that your petitioner enlisted in the Service of the State, early in the Revolutionary War, and Served more than Seven years, that he was in the battle of Black Stock's [Blackstock's, November 20, 1780],² under the Command of Col. Sumpter [Thomas Sumter], in the Battle of Kings Mountain [October 7, 1780]³ under the command of Colonels Campbell [William Campbell of Virginia] & Williams [James Williams of the Little River Regiment of South Carolina militia] in the battle of the Cowpens [January 17, 1781],⁴ under the command of General Morgan [Daniel Morgan] & Col. Pickens [Andrew Pickens], and in many other engagements of less importance, in all of which he discharged his duty as a Soldier to the Satisfaction of his commanding Officers, that during this Service your petitioner received Several wounds, particularly one in the Leg from a ball in the battle of Kings Mountain – and your petitioner further Sheweth that he was regularly discharged at the close of the War, but his papers have long since been lost or destroyed. That although poor he made out to support himself by his labor until within a few years – that he is now nearly Seventy years of age, and finds from the effect of old age, and the wounds and Hardships experienced in his youth, that his Strength and constitution is gone, and that he is no longer able to procure the comforts or even many of the necessarys of life by his own labor, on which himself as well as his aged wife are entirely dependent.

Your petitioner therefore prays that your Honorable body would take his case into, consideration, and place him on the Pension list, if it Should appear upon investigation that he is entitled to that relief.

And your petitioner as in duty bound will ever pray -28^{th} September 1825 S/ John Hicks, X his mark

The humble petition of Sarah Hicks begs leave to show that she is the widow of John Hicks late of Barnwell District – who was enrolled on the Pension list of this State – that the said John Hicks died several years ago which your honorable body will procure by the suspension of his Pension leaving your petitioner in indigent circumstances that she is now about eighty two years old; Since the death of her husband John Hicks she has been thrown on the charity of her widowed daughter who is poor and has four orphan children to support. Therefore she begs that

Peyton a Magistrate for Barnwell District & in the State aforesaid Tarlton Brown and made oath that he was personally acquainted with John Hicks and Sarah Hicks wife of the said John Hicks for fifty years until the death of John Hicks almost eight years since that he believes the said Sarah Hicks is still alive they were always considered by him and the neighborhood in [which] they lived as man and wife and further he never heard any objection to their being lawfully married the said John Hicks was with him during the war of the revolution and served as a private in his company. He further believes that the said John Hicks has been receiving pay from the State for his Revolutionary services.

The humble petition of Frances Reeves widow Sheweth to your Honorable Body that she is the daughter of Sarah Hicks pensioner of the District & State aforesaid & that her Mother Sarah Hicks did reside with your petitioner many years previously to her death & was residing with her at the time of her death & will petitioner further Sheweth that she is in indigent circumstances & has a large family of helpless children entirely dependent on her for support, Therefore your petitioner prays with your Honorable Body to grant her the arrearage Pension of her Mother Sarah Hicks for which a certificate was issued at the Treasurer's Office last December which your Honorable Body may perceive by the certificate hereunto annexed, & your Petitioner further Sheweth that her Mother Sarah Hicks died before the Tax Collector paid it over, Therefore your petitioner prays your Honorable Body to take the same into consideration & Grant her the amount of the Certificate & she will as in duty bound ever pray
