[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 5: Is the printed form of Indent No. 369 Book Y dated November 29, 1785 and issued to Thomas Hill for 61 days as a footman under Captain Thomson [Robert Thomson] during 1781 and 71 days as a Horsemen during 1782. In 1782 he served 38 days under Captain Gray [Frederick Gray]. This information is pieced together from the information in Bobby Gilmer Moss's *Roster of South Carolina Patriots*, page 446 and from the roster compiled by JD Lewis and posted at <u>https://www.carolana.com/SC/Revolution/patriot\_military\_sc\_privates\_h.htm</u>. The reason I have had to rely on these sources is that the image of the description of the veteran services as set forth in the Indent posted online is illegible.]
