[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Speaker & members of the House of Representatives of the State of South Carolina –

The Humble petition of Arthur Hiott Sheweth,

That in the early part of the Revolutionary War your petitioner Entered the American Service as a common soldier under the command of Capt. Tom [or Jeue] Porter² [? Capt. Jehu Postell of the Georgetown District Regiment or Capt. Thomas Post also of the Georgetown District Regiment] and continued under his command for in the vicinity of Georgetown & Cat Island for the Space of fourteen months, that he Afterwards Enlisted under one Capt. Hogan [James Hogan] who was attached to the fifth Regiment of South Carolina, commanded by Col. Isaac Huger, where he remained for the term of three years, after which he Served some time as a volunteer under Capt. Henry Council,³ in which service he was taken a prisoner by the Tories & by them after suffering much [at this point, the image of this document

If anyone has a legible copy of this document which they are willing to share with me I would appreciate receiving it] [p 2 of the petition] moderate degree of prosperity with which he has [undeciphered word] been blessed, that he would have no further necessity for it, that discharge has been lost, that he has made diligent inquiry to find some of the surviving officers under whom he served, but without Effect, that he is now in his 78th year of his age, with a wife who depends upon him for subsistence who is advanced to nearly the same Extent of years, that he is infirm and ruptured in such manner that it [is] with difficulty he can perform the most easy labor, that in common with many other of his fellow Soldiers who fought in those "times which tried men's souls" he received but a small pittance for the services he rendered, that he is now without property & without the hope of subsistence unless it be from the [undeciphered word] of the Honorable the Legislature.

Your petitioner therefore prays that your Honorable Body will take his case into consideration and grant him such relief in the premises [the balance of the document is illegible as posted online]


