Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Memorandum

As there was a Number of men together I took the Opportunity of selling the tents Kettles &c being smocked [sic, smoked?] and Damaged and kettles Bruised and beat almost to Pieces thought if [undeciphered word] – they would be Lost as they were already Rendered useless; and Indeed had Scarce a Posibility of Moving [?] at any Safe Place for want of horses and Cariage therefore Imagined it better to Soll [sic, sale] for the Public than that they should be Entirely Lost – S/ Richard Richardson
