The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The Petition of George Hoge [Sic] Humbly sheweth

That in the year 1779 in the month of February – he furnished the Troops of this state then in the service of their Country With a Waggon teeam & Driver for twenty one Days afterwards Sirved in Colonel Brattons [William Bratton's] Regimint as a Sergant for the space of twenty Days – & at the time he ought to have Laid in his Clame he was out of the Limits of the State Your Petitioner therefore Pray that Your Honourable body Will take his Case into your Most serious Consideration & Grant him such Relieaf as you in your Wisdom shall think Proper & your Petitioner as in Duty Bound Will Ever Pray &C
