[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 2: Printed form of Indent No. 22 Book O dated January 18, 1785 "delivered to Mr. Looney Robert (say) Robt. Looney this our INDENTED certificate for the Sum of Fifteen pounds Seventeen Shillings and one penny half penny Sterling for mending and Keeping in repair Arms of Capt. Tutt's [Benjamin Tutt's] Independent Company of Militia in 1780 per Account Audited."]

[p 3: Reverse of the above Indent bearing endorsements by Robt. Looney who signature thereon appears as follows:



[p 4: Printed form of Indent No. 547 Book W dated August 24, 1785" delivered to Mr. Robert Looney this our INDENTED CERTIFICATE, for the Sum of Twenty three pound ten Shillings and four pence for 439 Days Militia Duty in Capt. Tutt's Company in 1779 and [undeciphered word or abbreviation] per Account passed by the Commissioners of Accounts."]

[p 5: Reverse of the above Indent upon which there is only one endorsement and it is dated October 1785 and is signed by Thomas Lehre. Lehre was a speculator in the indents issued to veterans. How he acquired an interest in this indent is not disclosed by the documents in this file.]
