Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the President and Members of the Senate the Speaker and Members of the house of representatives of the State of South Carolina

The petition of the Subscriber humbly Sheweth that his brother Thomas Prince was at the battle of Stono [Stono Ferry, June 20, 1779]<sup>2</sup> in this State in the Revolutionary War was a Lieutenant in Capt. John Bowie's Company of South Carolina infantry, that in the action he was wounded by the british – from there he was taken to the hospital in Charleston where he died of his wound leaving no family – that your Petitioner is his only Surviving brother therefore prays that you would grant to him the Sum Commutation heretofore allowed his brother Officers of the Same Company and as in duty bound he will ever pray.

I John Bowie, do hereby certify that the above named Thomas Prince was a second Lieutenant in my Company of State troops during the Revolutionary War, or until he received a mortal wound of which he died. To his merits as an Officer, and his bravery as a Soldier, I cheerfully bear testimony. As an Officer, he was intelligent, active & enterprising – As a Soldier he was

The committee on Claims to whom was referred the Petition of Henry Prince Heir to Thomas Prince praying payment of Commutation – beg leave to report

That they have had the same Under Consideration. And find that the Petitioner had a Brother who Served in the Revolutionary War as a Lieutenant under Capt. John Bowie and was in the Battle at Stono where he received a Wound, all of which he died. That the Petitioner is the only Surviving Brother and he thinks therefore, entitled to the commutation that his Brother had he survived the revolution Would have been entitled to – But your Committee are not Satisfied as to the time & services performed by the Deceased (Mr. Prince) Under whom the Petitioner claims and as they doubt very much the propriety of Granting commutation to collateral Heirs They would beg leave respectfully to recommend that the prayer of this Petitioner be not Granted.
