[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Senate, and House of Representatives –

The humble Petition of Thomas Hopkins Sheweth that he was a soldier of the revolution, that he enlisted in the year 1780 and Served two years & 6 months in the State of South Carolina, under General Green [Nathanael Greene], Decalb [Baron Johan DeKalb], & Smallwood [William Smallwood] & Gates [Horatio Gates] was at Gates defeat [Battle of Camden, August 15-16, 1780], Battle of Camden, at the taking of Fort Thompson [February 22, 1781], Fort Friday [Friday's Ferry, May 1, 1781], at the Siege of 96 [May 21-June 19, 1781]. At Eautaw Springs [Eutaw Springs, September 8, 1781]. That he is now Seventy four years of age and very infirm, and poor, so much so that the Commissioners of the Poor of the District have had to take his case into consideration and assist him, in order to keep him from sufferance —

Therefore he Petitions your Honorable Body to Grant him an annuity such as shall Seem proper to your Honorable Body – and your petitioner will ever pray – 10 November 1836
