Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable \wedge [undeciphered interlineation] House of Representatives We Your Humble petitioners Officers of the late State Regiment of Light Dragoons commanded by Daniel Horry Esq. raised by virtue of an Act of the Legislature of this State passed in the year seventeen hundred and seventy nine Having not received that Commutation allowed to Officers of the Continental Army which we conceive ourselves entitled to We humbly request you would take our case into consideration that we may have these our claims granted. When the Regiment was raised we were by a Clause of the Act to be allowed the same subsistence Money that was allowed to Continental Officers of the same Rank, and by the said Act was upon the same footing, being liable to do duty out of said State if required, it so happened to us when the British Army took possession of Charleston and were marching to George town we went on to the Northward our Men's times they were enlisted for being most of them out, they would stay no longer but having our Commissions which made us Officers during pleasure we could not do less than join the Northern Army. After the defeat of General Gates [Horatio Gates at the Battle of Camden, August 15-16, 1780] our State claimed no services one of us joined General Marion [Francis Marion] the other General Sumpter [Thomas Sumter] and from that time until the War was won we were in service of our Country. We therefore hope the prayer of our petition will be granted for which Your petitioners will ever pray
