[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[Note: There is no Audited Account file for a veteran by the name of David Buckhalter. The following document appears on page 20 of the file relating to William Huggins. The portion relevant to David Buckhalter reads as follows:

On the petition of David Buckhalter Your Committee Report, that the said Buckhalter had formally been on the pension list, and had Received his Pension Several Years, that on Application to the Treasurer, in Columbia, – in the year 1793 – his Pension was withheld from him, by Benjamin Waring Esquire, then Treasurer on Information, that the said Buckhalter, did not Receive his Wound, from the Enemy – But it appears to your Committee that said Buckhalter, Received his Wound, in the Service of his Country while preparing to meet the Enemies of his Country at Liberty hill –

Your Committee therefore Recommend that the prayer of the petitioner be granted – that, he be, Reinstated on the pension list – from 1793 – & arrears be paid him – ....
