I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

That your petitioner was put on the pension List sometime past, that for sometime last past your petitioner was compelled from extreme necessity to reside in the State of Georgia which has prevented your petitioner from receiving the Money actually due her by the State the Sum actual do your petitioner from the State is __ Dollars & __ Cents which Money your petitioner now prays your Honorable Body to pay her.

And your petitioner as in duty bound will ever Pray. 1812 26th November S/ Sarah Hughs, X her mark

To the Honorable Senate of South Carolina

Sheweth,

That your petitioner had the misfortune to loose [sic] her Husband Dempsey Hughs who was killed fighting the Battle of his Country in the Revolutionary War between America and Great Brittain and that your petitioner was placed on the pension list of South Carolina that from her extreme poverty, having no place of Residence and very little to subsist on she was compelled to reside in the State of Georgia with her friends but now being afflicted with the Rheumatic pains and also overtaken with all debilities of old age she is dependent for every Comfort of life, and thereby Constrained to petition Your Honorable body to continue her pension and Grant her the arrears of pension now due her. –
