Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Mr. Huston Informs me he has Returned a pay Bill into your Office for one hundred & two days not knowing he had a right to any more than that as that was a kind of irregular Tower [tour] Entered Into by all those who first turned out in these parts – But as I am well acquainted with the gentleman and knows him to be person of merit and also knows he Did perform the Duty as above Stated I hope youll be so Obledgeing as to Destroy the first bill and Receive this into your office
