[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The petition of David McDonald of Fairfield District, Humbly Sheweth, that your petitioner was a true friend to his Country & a Soldier in the Revolutionary War, his first tower [tour] was to Orangeburg, & from thence to Charleston under Capt. John Turner, & Col. John Winn, the next Joined Genl. Sumter [Thomas Sumter] after the battle of the hanging Rock [August 6, 1780], & went alone with Sumter to Carey's old field there Captured 75 Scotch Grenadier's & took 32 Waggons Containing provisions for the enemy, the next he was at Sumter's Defeat [Fishing Creek, August 18, 1780], the next rounds he went, he went the rounds with Genl. Sumter down to Friday's Fort, & then to Tompsons [Thomson's Plantation] & took

some Waggons with provisions & put aboard of boat & was captured at Right Bluff [Wrights Bluff], the next campaign was when Genl. Green [Nathanael Greene] was making his retreat from Ninety Six & marched on to Orangeburg, from thence Genl. Green marched on to the high hills of Santee & marched with Genl. Sumter & Marion [Francis Marion] down to Moncks Corner & then across the head of Cooper River, to where an action took place down by Haddrell's Point, & then retreated & crossed Nelson's ferry, & then lay 8 days at the Alogator lake [sic, Alligator Lake?], & then home, the next trip was taking Friday's Fort, the next trip Orangeburg & made a three months trip — Your petitioner is about 68 or 69 years of age, he has two sons & one daughter yet living with him your petitioner puts himself on the benevolence of his Country & the Wisdom of their Honorable body the Members of the State Legislator, hoping their wisdom will take into consideration the prayer of their petitioner, & their petitioner will ever pray.
