Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. The petition of Jesse Jordan Sheweth that he was a Soldier of the Revolution, that he served under the command of Colonel George Hicks and Colonel Kolb [Abel Kolb] & various other officers & was in the service at the end of the war. Your petitioner further states that he is in indigent circumstances as will appear from his Schedule hereto annexed, He therefore prays your Honorable body to grant him a pension and that his name may be placed on the pension roll -
