The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable Senators and members of the House of Representatives of South Carolina
The Humble Petition of William Beckham Sheweth to your Honorable body that he is a
Son of the who Served as a first Lieutenant in the Revolutionary War for upwards of two years in
the Militia of South Carolina, and suffered many of the Privations of that Period, That he is the
Legitimate Son of the said Thomas Beckham; your Petitioner would pray your Honorable body
to take into consideration his destitute Situation and grant him such relief as is provided by the
State of South Carolina for Heirs of Revolutionary Soldiers.

Your Petitioner would further set forth that the said Thomas Beckham never received a pension from South Carolina nor from the United States for his said Services; and your Petitioner deeming himself entitled to what his Father would be were he now living, would pray your Honorable Body to grant him the said Amount if to your Honorable Body it would seem meet.

Your Petitioner would further pray that your Honorable Body would place his name upon the Pension Roll; and alleviate his needy condition and your Petitioner will ever pray and so forth.

I Colonel Samuel Hammond being called on and requested to give a statement of what I know of the Revolutionary Services of Thomas Beckham Edgefield District Deceased,

I state that I knew him in the winters of 1778 & 1779 as Lieutenant in Colonel Leroy Hammond's Regiment of South Carolina militia, I knew him in my Official Capacity. His name being on a Roaster [sic, roster] of Duty.

I continued to know him in Service during That Campaign; I still continued to him in my Official Capacity on his March to and during the Siege of Savannah² – After that I knew nothing of his Services until the fall of Charleston, in May 1780 when he was made Prisoner of War, by a convention entered into between General Williamson [Andrew Williamson] and British Authorities – I then retreated with a small Number of Volunteers to North Carolina During which time I knew nothing of him. On my return to South Carolina a short time Previous to General Green's [Nathanael Greene's] Siege of Ninety Six [May 21-June 19, 1781] Captain John Martin with the said Thomas Beckham as his first Lieutenant with a number of others Joined my Regiment and continued with me at Augusta during the Siege and Surrender of Brown's and Grierson's Forts;³ After this Colonel Leroy Hammond resumed his Command of his own Regiment of militia having been released from his Parole; at that time I commanded a Regiment of Dragoons, State Troops and marched with them under the command of General Pickens [Andrew Pickens], to Join General Greene North of Broad River, and he the said Thomas Beckham continued in Service as first Lieutenant under Captain John Martin until and after the Battle of Eutaw Springs [September 8, 1781] – that night after the said Battle I was Detached from the Army and knew nothing more of his Services.
