[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Thomas Brandon and that he Never Got said Gun nor any satisfaction for he is & if he Gets said Gun he will Return him to the Commanding Officer of the Regiment or the Value thereof to the Publick [undeciphered word] Charleston Sworn before me S/ Wm Ja[paper damaged and text missing]

[pp 24-42: Relate to petitions by a man by the name of William Kennedy who states that he is a pensioner of the State of South Carolina having previously lived in Union District South Carolina but now living in Blount County Alabama Territory. The file does not contain any documentation relating to the initial granting of the pension. All of the documents relate to his attempt to get the arrears of pension due to him since he moved to Alabama. He sings all of the documents with his mark. In one of the documents he refers to a wound but does not give any particulars regarding when or where he was wounded.]
