I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Smith's Compagnie took two Horses, one of them was in Service of the florida Expedition 84 Days,⁴ one Sorrel mare taking By Capt. Milling was in Service 15 Days, and for the other Horse this Dept. [Deponent] Did not receive him as jet [yet] and this Dept. further Saith that he Did not receive Payment for them as jet and further Saith Not. Sworn to before me
