[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[Note: Beginning in 1829 this file contains documents that indicate that an illiterate Revolutionary war soldier by the name of Joseph King had been granted a pension of \$60 per annum for his service in the revolution each of the documents calling for his signature are signed with his mark. Unfortunately the file does not contain the veteran's petition itself so there is no way to know what services he claimed. The vouchers in the file signed by the veteran with his mark reflect that he was still alive as of April 11, 1834 and was receiving his annual pension of \$60 open until that date. This veteran was a resident of All Saints Parish. This Parish was located in the Waccamaw Neck in what has become Horry and Georgetown Counties South Carolina.]
