Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention.]

The humble petition of Mary Bell, widow of James Bell deceased respectfully Sheweth unto your Honorable Body that her husband being wounded in the Revolution was allowed by the State, an annuity of \$21.42 – which said annuity he received up to March 1797 that since which time to wit, on the 18<sup>th</sup> day of January 1801 your petitioner's husband departed this life – leaving the said annuity undrawn paid for three years and ten months before his death – Your petitioner therefore prays your Honorable house to take her case into consideration – and grant

South Carolina Union district} Personally came Mary Bell the widow of James Bell deceased of said district [one or more words too faint to discern] oath that her said husband did departed this life on the 18<sup>th</sup> day of January 1801 & that as he was wounded in the service of his country & that I have not made application for my annuity that is allowed by Law to the Widows of wounded persons & that She has not drawn any of the Public money since the decease of her said husband Either more or less – Sworn to & Subscribed this 21<sup>st</sup> day of November 1813 before us. S/ Mary Bell, X her mark

South Carolina Union district} We do hereby certify that we knew the husband of Mary Bell was wounded through the body by which wound he was disabled from hard labor in such a manner that he could not make his living by labor & that he did get his wound in the actual service of his country at or in a battle at Musgrove's Mill [August 18, 1780] against the British & Tories & that we do think the said widow Mary Bell is Justly Entitled to the Lawful annuity of five pounds a year Ever since the death of her said husband from the State of South Carolina.
