[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 2: The cover sheet for this claim is illegible as posted online. However on page 5 of this file is the printed form of Indent No. 288 Book P dated April 19, 1785 "delivered to Mr. William McMahan [sic] this our INDENTED CERTIFICATE for the sum of Seventy eight Pounds five Shillings Sterling for Militia duty & Sundries in 1780, 1781 and 1782 per Account Audited."]

[p 3: Partially legible statement of the veteran's claim which to the best of my ability indicates that he served in the militia under Capt. Freeman² in 1780 & __ for which he was given £16 old South Carolina Currency; also for duty per Col. Robert Anderson's return [not extant] amounting to £423.15 old Currency; 22 days Waggoning service at 4 pounds per day for which he was given £88 old Currency; and for 400 pounds of flour at £5 per hundred for which he was given £20 old Currency for a total of £547.15 old South Carolina Currency or Sterling £78.5]

By order of Colonel Robert Anderson to William McMahen Liut. Gave 400 lb of flower for the use of the publick the 15th of Jully 1782

To the Honorable the President and Members of the Senate of the State of South Carolina
The petition of Major John Calhoun most humbly Sheweth that your petitioner purchased
a publick account of a William Mcmahen for seventy seven pounds seventeen shillings or

thereabouts which was due to said McMahen for services done in the late war and your petitioner made application at the Treasury office for his Indent but found that it was previously drawn out of the office by some person not known to your petitioner by a counterfeit order. – Your petitioner likewise purchased a publick account from Isack Mitchel [Isaac Mitchell] for 90 Bushels of Corn which he the said Mitchel furnished the Army with while laying Siege to Ninety Six – at three Shillings and six pence per Bushel And your petitioner having duly served his country through the course of the last war Received a number of wounds particularly that ingadgement [engagement] now known by Tarleton's defeate [Battle of Cowpens]: 4 your petitioner was disabled and was obliged to imploy persons to attend on him to whom your petitioner paid tenn pounds for which your petitioner never received any compensation and has receipts to show your Honors for the payment of the Same Nor has your petitioner ever received, any thing for the above stated Publick accounts which now lyes dormant in his hands Now your petitioner prays your Honorable body to take his case into consideration and grant him such relief as you and your wisdom shall see Meet. 5
