[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 2: There is a cover sheet for a claim the image of which is mostly illegible as posted online. It does not appear that an indent was issued based on this claim as there is no reference to an indent in this file. What can be discerned from the cover sheet is that the veteran claimed service for duty as a lieutenant since the fall of Charleston on May 12, 1780; also for wagon hire and a horse lost in 1779. Some of the documents transcribed below shed further light on this claim.]



Petition of John B. Covington praying compensation for services rendered by the late Fields Pardue in the War of the Revolution


To the Honorable the Senate and members of the House of Representatives of the Legislature of South Carolina.

The petition of John B. Covington respectfully Sheweth to your Honorable bodies that in the war of the revolution the late Fields Pardue was appointed and commissioned a Major

in a Regiment of which Col. Samuel Hammond was a Lieutenant Colonel, to which Regiment was added to Companies of Mounted Rifle men, that the operations of said Regiment was confined to the State of South Carolina during all the time the said Fields Pardue Served therein as a Major and that he Served out the full period of his engagement, during which time he received a wound that ultimately caused his death, that the said Fields Pardue was entitled to three Negroes, as a compensation for his Services as Major in said Regiment, and that Negroes at that time was reasonably worth the sum of ______ dollars a head: that the said Fields Pardue in his lifetime never received any compensation for his Services so rendered, from the State either directly or indirectly nor from any other Source whatsoever, neither has any other person or persons whomsoever received the same on account of said Pardue, your petitioner further Sheweth, that Gideon Pardue, Susan Pardue, Patsy Pardue and Lucilla Pardue now Lucilla Covington are the children and Legal Representatives of Fields Pardue, Therefore your petitioner prays your Honorable body's, that the said Gideon Pardue, Susan Pardue, Patsy Pardue, & Lucilla Pardue, May received from the State due Compensation for Services rendered by their father the said Fields Pardue in the war of the Revolution, as aforesaid, and your petitioner will pray &c

South Carolina in Edgefield District} Personally appeared before me, M. Gray, a Notary Public in and for the District aforesaid, Col. Samuel Hammond,³ who being duly Sworn, Saith on his oath, that he was well acquainted with the late Fields Pardue, That [undeciphered word]⁴ the war of revolution the Said Fields Pardue was appointed and commissioned a Major in a Regiment, of which this deponent was a Lieutenant Colonel, & to which was added two Companies of mounted Rifle men, that said Pardue was entitled to three Negroes for his Services as Major in Said Regiment, that Negroes was at that time worth the Sum of Eighty Pounds each, that the Services of the said Fields Pardue was confined to the Said State during the time that he Served in Said Regiment, that he Served out faithfully the period of his engagement, during which time he received a wound while in the performance of his duty, which ultimately caused his death. This deponent further Swears, that he has no knowledge of said Fields Pardue ever having received any compensation either directly or indirectly, for his Services, from the Said State, or from any other Source whatsoever, neither does he Know of any other person or persons whomsoever having received the same on account of said Pardue, and that Gideon Pardue, Susan

² Men who enlisted for ten months in April 1781 in the SC State Troops of Light Dragoons under Hammond were promised wages payable in slaves taken from the Tories. Such 'pay' was known as "Sumter's Wages." When the number of confiscated slaves proved inadequate to pay this horrendous form of payment, the South Carolina Legislature authorized the payment of £94 Sterling in lieu of one grown Negro slave.

To the Honorable the President, and other Members of the Senate of South Carolina

The Comptroller General to whom was referred the Petition of John B Covington, praying for compensation for services rendered to the State in the War of the Revolution, by the late Fields Pardue a Major in the Regiment commanded by Colonel Samuel Hammond Reports, that he has examined into the facts of the Case as far as it was practicable for him to do; That in conducting the examination, it appeared that to facts only were required to be established, first the performance of the Services, stated to have been rendered, and Secondly, the fact of no compensation having been made for those Services. The evidence which was adduced to Substantiate the first point, (and which accompanies this Report) is of the highest Character. It is the Testimony under Oath of Col. Samuel Hammond, who was the immediate Commander of the Regiment, in which Major Pardue is said to have served; Col. Hammond a Gentleman of high Reputation, and of distinguished ability and Zeal in the Revolutionary War, Testifies in the most unequivocal manner to the identity and the Services which were rendered by Major Pardue as an Officer in his Regiment, and holding the Commission etc. it as set forth in the Petition. The testimony in support of the Second point (as to compensation) is of a negative character, but is strongly confirmatory of the Statement in the petition that no compensation was ever made to Major Pardue in his lifetime, or subsequently to any of his Representatives for Revolutionary Services; The first is the affidavit of Col. Hammond, that he does not Know of the Said [out of sequence p 24] Fields Pardue ever having received any compensation from the State for Military Services rendered during the War of the Revolution, or of his Representatives ever having received anything on that account. The next is the entire absence of documentary or of any other proof that compensation was made to the said Pardue or to any of his Representatives for Military Services. The records in this office do not furnish any evidence that a Settlement was

ever made with any of the parties in this Case. The [undeciphered word]⁵ of evidence which the Registry in this office furnishes of Settlement for Revolutionary claims, and the total absence of all proof that any Settlement of the claims of Major Pardue was ever made induces the Comptroller to venture the opinion that the facts stated in the petition (and corroborated by the affidavit of Col. Hammond) are to be relied upon.

Your Committee have given the matter of the Petition a patient and jealous scrutiny, and are convinced by the very unexceptionable testimony brought before them, by reference to the necessary public documents and the Report of the Comptroller-General ordered to be made by a committee of the Senate last Session, that the prayer is a just one; and they unanimously recommend that the sum of two thousand four hundred and fifty nine forty 22/100 dollars be appropriated in satisfaction of it to be paid to the Heirs of Fields Pardue respectively.
