[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the President and others the Members of the Senate of the State of South Carolina –

The Petition of John Knighton – Humbly Sheweth

That your Petitioner having served in the late war under the officers Subscribing a certificate thereof hereunto annexed for a Considerable time, and having lost a Horse in the Service, for all which he has neither received Certificate, or Compensation, neither would he have looked for any – had not the distressed Situation he is reduced to by losing his Eyesight, incapacitated him to procure a Subsistence for himself – and having no dependence [sic], or means of Support but what comes from the Compassionate – He therefore humbly presents to this Honorable House the Consideration of his distressed Situation, hoping that his Calamitous Circumstances will induce you to do something for him in whatever way may [text obliterated and rendered illegible]

Petitioner as in duty bound shall ever pray November 28th, 1793

To the Honorable the Speaker and the other Honorable gentlemen of the House of Representatives the petition of John Knighton humbly Sheweth that your Petitioner did 18 months Service in General Marion's [Francis Marion's] brigade as will [word obliterated] by his certificate and also had a horse pressed into the service by Major Snipes³ for neither of which he has never received any compensation and he hopes your Honorable House will not take advantage of his being a poor blind man and could not get anybody to deliver in his accounts in time and he humbly hopes your Honors will grant him sum [some] relief and he will always pray for your Honors.



This is to Certify that John Knighton Served under me during the war in the militia and Did faithful duty as any man whenever he was called on and never received pay for any part of his duty nor yet Received any certificate a likely Brown Bay horse taken into the Service which General Marion promised that he should receive his horse at different times but never Received a horse nor certificate

This is to Certify that the Bearer hereof John Nighton [sic] Lived a Near neighbor to me two years in time of the British Invading this State and I have reason to Believe he Conducted himself as an honest Man – and friend to the American Cause, by doing his Duty In the Militia when called on – and that I know of no Compensation nor means of Coming at his pay, for Services done about that time.

Report -

That they have examined the Petition and the certificates and vouchers Accompanying the same and beg leave to recommend in the words of the unfortunate petitioner that no advantage be taken of his blindness and Poverty, but That the Treasurers be directed to pay him the Sum of Sixty Six pounds 13/4 to be provided for in the next year's tax bill
