Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the honorable the Speaker, & Members of the House of Representatives of the State of So. Carolina in Genl. Assembly met.

The Petition of Bethel Lamb humbly Sheweth

That your Petitioner was the wife of Jacob Lamb of this State, & of Orangeburg District, and that he was killed in an action by the Enemy in this Country on the 28th of August 1781, and at the time her Husband was killed, she had a Son named Jacob which was born on the 21st day of June 1781, which is now living and that she still remains a widow, and is not possessed of any Slaves, nor more than one hundred acres of Land. And that your Petitioner from inattention & ignorance of the Laws, have not made any application heretofore for any Annuity, which she now understands She is entitled to by Law.

She therefore prays your Honorable House to take her case into consideration, & that She may be placed on the list of pensioners & that she may receive Such annuities as is Justly due to her. And your Petitioner as in duty bound shall pray.
