[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

St. Peter's To the Honourable the Senate Speaker and Members of the House of Representatives:

The Humble petition of Sarah Lane Sheweth: That Drury Lane your Petitioner's Husband died on the 10th day of May last, and that there was then due him two months and ten days portion of his yearly Pension, which he had received from the State of South Carolina. The amount of this proportion of his pension your petitioner believes is Eleven 66/100 2/3 dollars. And as your petitioner is old, and needy, She humbly prays your Honourable body would take her case into consideration, and order the sum of \$11.66 2/3 to be paid her and your Petitioner, as in duty bound will ever pray &c

To the Honourable The Senate and Members of the House of Representatives of South Carolina.

The Humble petition of Sarah Lane Sheweth: that your Petitioner is the widow of Drury Lane a Revolutionary pensioner of St. Peter's Parish Beaufort District who died on the 10th May 1830. Your petitioner till recently was not apprised that there was an allowance of half pay appropriated for the Widows of pensioners; but having some time Since been acquainted with that Circumstance; your petitioner humbly begs your Honourable body would take her case into consideration (being very aged and poor) and order that the amount usually paid in such Cases be paid to her and your petitioner as in duty bound will ever pray &c
