[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Speaker and Members of the House of Representatives The humble petition of Simon Lee Sheweth

That your Petitioner is a native American and one who during the Revolutionary war with Great Britain served during a part of that war as Ensign in Sheperds [sic, Abraham Sheppard's] regiment and during the latter of the said War as Captain of a Militia Company attached to Colonel Eaton's [Thomas Eaton's] Regiment. That your Petitioner was during the war in several battles and engagements, and one of which, to wit, at the Eautaws [Eutaw Springs, September 8, 1781]<sup>2</sup> he was shot through one leg and through the [undeciphered word].<sup>3</sup> That your Petitioner is a poor man with a very large family and that from his wounds he is disabled from working so as to maintain his family.

it was said when he petitioned before that he should have come forward sooner the Reason of that was because he did not want to Run [?]<sup>9</sup> his Country to any Expense and strove as hard as possible he could to prevent the same But through old age and great Infirmness Compell him to Repetition to your honers [honors] again for some assistance it might be said that this should have been proved it was proved by the testimony of Thomas Bateman and by his Commission which was Lade [laid] before the honorable House and was granted of which he has Received five years pay

from North Carolina for the aid of South Carolina and Georgia and was taken a prisoner in the State of Georgia and if that is granted please to get it back as far as you can and in the next place try if you cannot get a certain sum of three or four years at once Deducting the Interest of Every year or else try and get me three or four hundred Dollars and Take me off the pension Roll and in the next please to have pensioners ordered so that no Debt can take it from them and that they shall not be cased or imprisoned for Debt for Major [undeciphered word or name]<sup>11</sup> cased me for Cost when it was not just a note of fifteen dollars was put into his hands and he went and write in stead of a summon and I have paid twenty five Dollars and then he put me in jail for the balance if in your power to prevent pensioners from that Law do as they have ventured those living [text obscured] the survivors after them and I remain [text obscured] 16 [undeciphered month] 1826

Ashes Defeat at Brier Creek in the State of Georgia on the third day of March 1779 and afterwards was paid off as Capt. by Major Clay then paymaster of South Carolina in the <sup>month</sup> of December 1779 – your Humble pertitioner prayeth That your honorable Body would place him on the pention roll as Capt. as my Commission has been sent to the assembly by Col. R. L. Witherspoon and the proof of my service are wounds. This is the prayer of your faithful Solger [Soldier] who served five years in the Revelution war November the 22 Day 1826 S/ Simon Lee Snr.
