[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina

To the President & Members of the Senate

The humble Petition of John Latham [sic]

Sheweth to your Honorable body that he done Service in this State & that of North Carolina in the Revolutionary war. He was not one of those who wore the name of a soldier, but done none of the duties [?] of a soldier. He Searched for the place where his Services would be most profitable, & then rendered them willingly. No danger, trouble or difficulty baffled him in any of his distress [?], but hazzarded all for the good of his Country. Your Petitioner was under the command of various officers & done duty in many places. In this State he was at Charleston when it was taken by the British [Charleston South Carolina fell to the British on May 12, 1780],² was at the battle at Blufords – Your Petitioner with four others were sent out upon a Scouting party was overtaken by a parcel of Tories, & by them your Petitioner was wounded by the Sword on the head, and on the hand. The wound on the head was a very severe One, the incision was made on the left side & the whole of the flesh & skin was so cut that the skin & flesh being [text too faint to discern] my ear & up me neck. I attempted to parry the strokes aimed at my head, & by this means received the wound in my left hand by reason of which he lost one of his knuckles. The cleft in the hand was a considerable one, & the injury done by it, I feel to this day. From the wound in the head Your Petitioner at certain times in cloudy weather feels pains; & is an annoyance [?] to him. Your Petitioner has long deferred to apply for any assistance from a State in which he has suffered so much but he is now getting old, & has no one to work for himself & a large family – His Children are all females & after so long a forbearance he hopes your Honorable body will grant him a pension



[Note: The prayer of the petition was granted and the petitioner was placed on the SC pension list at the annual rate of \$60 with the first payment being made on June 9, 1826 of \$120 to “John Lathern [sic]. Subsequent payments were made through May 30, 1831, all at the rate of \$60 per annum.]

To the Honorable the Senate & House of Representatives of South Carolina

The petition of Margaret Lathern [sic] Executrix of John Lathern late of Lancaster District deceased was 1 of the Pensioners of this State that he died on the 12th of October 1831 leaving a Will appointing me the Sole Executrix.

At the time of his death there was an Arrear of Pension due to him, up to the day of his death, which was on 12th of October, 1831, I therefore Respectfully petition your body to grant me the Arrears of Pension whatever Amount may be found due my Testator. The above is Submitted by your Petitioner
