The petition of Priscilla Lyles humbly

Sheweth.

That your petitioner's husband David Lyles, Enlisted in the 6<sup>th</sup> Regiment of this State under Capt. Daniel Jackson, and that he died in the service of said State (which will appear by the Certificate of Capt. Jackson accompanying this petition) and that the petitioner has labored under great [paper damaged and text obliterated] through the loss of her husband, and most seriously solicits your Honorable body to take her case under your consideration and grant her such relief as is provided by law for widows in such cases. – And your petitioner will ever pray S/ Priscilla Lyles, X her mark

Spartanburg County Appeared before me William McDowell a Justice for the said County Priscilla Liles and being Sworn in due form of Law Deposeth and sayeth that her Husband David Liels [sic] Being a Soldier in the State troops died in Charleston in the year 1777 and that She remained a Widow and that She never Received Any Bounty or maintenance from the publick
