Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Greenville} Personally Came William Linch [William Lynch?] before me and made oath that on the Third day of July 1776 he was attacted [attacked] (in company with a few other Persons a trying to collect the Property of a number of Persons who had bean [been] forst [forced] to liave [leave] there [their] Houses & Plantations) By a number of Cherokee's Indians,<sup>3</sup> who was a laying in ambush, and that he was wounded in the Right Eye which occasion'd the Loss of the Sight of that Eye, and it has So affected his head otherways that He Balleaves [believes] it has occasion'd a number of other Complaints to attact.<sup>d</sup> [attack] his Body. Sworn to & Subscrib'd before me this 28<sup>th</sup> October 1816
