I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[text obliterated]³ Regiment of State troops and I do hereby by these Presents make good my right from all claim or Claims whatsoever witness my hand and Seal this 31st day of August 1782 Witness

² Men who enlisted for ten months in April 1781 in the SC State Troops of Light Dragoons under Sumter were promised wages payable in slaves taken from the Tories. Such 'pay' was known as "Sumter's Wages." When that horrific form of payment could not be made because too few slaves were confiscated from the Tories, the SC Legislature authorized the payment in pounds Sterling deemed to equal the value of the slaves not delivered.

³ I believe (but can't prove) that his man probably served in Lt. Col. Samuel Hammond's Regiment of SC State Troops. I base this opinion on the fact that a William Little attested in <u>George Cowan SC1616</u> Audited Account that he, Little, saw three other veterans of Hammond's Regiment assign their rights to "Sumter's Wages."
