

[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable President, and the Honorable Members of the Senate, the humble petition of William Loyd [sic] Sheweth that your petitioner was wounded during the late revolutionary War, in the Service of his Country when under the command of Genl. Marion [Francis Marion], which has rendered your petitioner unable to Support himself and Family; Your petitioner is a poor Man with a Small family therefore trusts that your humanity and generosity will afford him Such

² In Samuel Johnson's Dictionary of 1755, the first definition of the word "meet" he gives is "Fit; proper...." Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.

The Committee on pensions to whom was referred the petition was of Dorcas Lloyd, Martha Williams, and Mary Linch [? Mary Lynch] praying for the arrears of pension due to their deceased Husbands –

Report that they have duly considered the same and recommend that Each of them be paid the arrears of pension that the Comptroller General may find would have been due their deceased Husband's at this time.

The committee on Pensions to whom was referred the Petition of Dorcas Loyd [sic], praying for the arrears of Pension Due to her late Husband, Respectfully Report that having the same under Consideration Recommend that the Arrears due to her late Husband be paid unto her, and that the said Dorcas Loyd be Substituted on the Pension List in the loop of her Late Husband, December 1822.

[Note: Throughout the documents relating to her, the widow's name appears to be spelled Darcas Loyd or Darcas Lloyd, but I have used Dorcas because that is the only form of the name I've ever experienced.]
