I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Please to deliver to Mr. Archibald Taylor an Indent due Major William Benison Deceased for Services due him, as Major of Cavalry in Colonel Peter Horry's Regiment (Reference being had to his regimental Pay Bill now in your Office in which are his Pay, Mentioned as Major, & also the Sum allowed as Rations), also the full Interest on the same and his receipt will be a full discharge for the Same. Am Gentlemen your Humble Servant
