Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Side Saluda [Saluda River] for which the Grant is obtained & one Tract of 222 Acres another of 90 Acres both So. of Saluda the Grants in the Office – all in my own name & all at 10 Dollars per hundred Acres – as the hundred Acres No. of Saluda is below the old Boundary Line

Given under my hand this 1st day of October 1788

William Mackie [sic] did acknowledge the above order before me & I do Further Certify that although William Mackie Generally signs his name but at this time he cannot even hold his 10 with his right hand Occasioned by Rheumatick pains but made the Mark with his left hand before me
