Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Senate and House of Representatives of the State of South Carolina The Humble Petition of John Malphurs

Sheweth

That during the Revolutionary War in which your Petitioner served as a Member of a light Infantry Corps commanded by Colonel John Baker⁴ he lost during an attack on what were called the Florida Scout and Indians at or near the Saw pit Bluff [Sawpit Bluff]⁵ a Mare, saddle and Bridle, with a coat and Blanket (all of which was his private property) for which he has never received any compensation. Your Petitioner would not now in this late period of time have made application to your Honorable Body for compensation for this loss in as much as he has heretofore been able to support himself by his own exertions; but pressed as he is by the hard of want in his Eightieth year he is compelled to advance this long withheld though just and honest Claim. He has also looked for a year or more to that compensation promised by Congress to the Soldiers of the Revolution; but his humble claim obstructed and delayed by petty and too exact manners of form has as yet been unheeded and unanswered. Under these circumstances your Petitioner now comes before your Honorable Body and humbly prays that the prayer of his petition may be granted
