Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]



96 District SS Personally came Roger Martain [sic] & made Oath that in May 1779 he was Ordered by Capt. John Cowan his Officer on duty to Repell (as We understood) a party of the British that was Said to be Incamped at Bryer Creek [Briar Creek] in the State of Georgia he was ordered on Horseback, & on the Said Expedition in the State of Georgia, his horse was stole, as he believes by the Enemy, he the Deponent Saith he Came home on foot & sometime after went back to Look after his said horse & found him in the possession of a party of the Georgians on Duty at Beach Island, commanded by Col. Twigs [Col. John Twiggs of GA], they Refused to give up the Said Horse, without he would pay three hundred Dollars, which they Called Salvage, as they said they Retook him from the enemy upon which the Deponent Saith he paid the money viz. £487.10/ old Currency in paper money & got his horse for which he has never Received Pay.
