[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Hammonds [Samuel Hammond's] Regiment<sup>2</sup> of State Troops this our INDENTED CERTIFICATE for the Sum of One hundred Seventeen pounds ten Shillings Sterling being the Ballance of Pay and Bounty due him for Services in that Regiment Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the Eleventh March last &c."]

[p 4: Reverse of the above Indent bearing, among others, the following endorsement:

I do hereby assign the Contents of the within Indent of one hundred seventeen pounds ten Shillings to John Hammond or his assigns in full affect it being for Value received of him this 16<sup>th</sup> June in the year of our Lord Christ 1785

<sup>&</sup>lt;sup>2</sup> Men who enlisted for ten months in April 1781 in the SC State Troops of Light Dragoons under Hammond were promised wages payable in slaves taken from the Tories. Such 'pay' was known as "Sumter's Wages." When the number of confiscated slaves proved inadequate to pay this horrendous form of payment, the South Carolina Legislature authorized the payment of £94 Sterling in lieu of one grown Negro slave. Sergeants in said Regiment were entitled to 1 ¼ grown Negroes.



- [p 5: Printed form of indent No. 33 Book O dated January 19, 1785 "delivered to Mr. Simon Martin for this our INDENTED CERTIFICATE for the Sum of One pound twelve Shillings and four pence Sterling for duty as a Constable in (96) District in 1783 per account audited."]
- [p 6: Reverse of the above Indent indicating that Simon Martin used the principal to purchase land.]
- [p 9: Printed form of Indent No. 500 Book T dated June 27, 1785 "delivered to Mr. Simeon Martin [sic] this our INDENTED CERTIFICATE, for the Sum of Eleven Pounds, One Shilling, & nine Pence Farthing Sterling for militia duty as Sergeant per Account Audited."]
