Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Members of the Senate, & of the House of Representatives of the State of South Carolina

The Humble petition of Samuel Matthews, Sheweth

That he is a native citizen of Abbeville District in the State of South Carolina of the age of Sixty eight years, that he has constantly resided from the period of his birth, in Abbeville District where he raised a family who are now dispersed, at a great distance from him, in Several quarters, and unknown to him, that he is left destitute of support except that arising from his daily exertions which are now feeble from age, and rendered more so, from diseases, of acute Rheumatism, and White Swelling the effects of which, are visible, and felt by him in the Right Knee, and Right Shoulder, these United afflictions, have made him in some degree a cripple, Your petitioner further States, that during the Revolutionary war, he was in the ranks of his patriotick countrymen, protecting the property of individuals from Tory depredations & plunder for this purpose he joined a Company commanded by Samuel Reid [Samuel Reed] he subsequently joined the Companies of Captains Irwin [John Irwin] & Patterson [sic, probably Lt. Josiah Patterson], with each of whom, he served one month, these Officers, during the time he served with them were commanded by Major Alex Noble [Alexander Noble], who with General Andrew Pickens, were with Genl. Green [Nathanael Greene] at Bacon's Bridge in the low country of South Carolina. Your petitioner mentions these circumstances not as a claim which he merits in consequence of them, but merely to show his true character, his occupation from early

youth has been that of a laborer, and of late years, a sewer [?]² of wood, and occasionally other avocations, of the most laborious and oppressive character with a firm reliance upon the benevolence of his native state, he submits, his petition for relief, to the consideration of its enlightened Legislature.

Greene at Bacon's bridge during the Revolutionary War, that the petitioner has always Sustained the character of an honest man, and a firm patriot and friend of his country. I Daniel Gillespie swear that I knew Samuel Mathews during the Revolutionary war: he was a good Whig, and several times did service in the militia whilst I was in service.

Once we went together, he under Capt. Dawson,⁴ and I under Capt. Jos. Calhoun [Joseph Calhoun] in pursuit of Wm Cunningham [William Cunningham a/k/a William "Bloody Bill" Cunningham] & a gang of Tories, at which time we went through Bate's Swamp, & were out about 3 weeks, much exposed.

At another time, we went both under Capt. Dawson, and joined Genl. Greene's Army whilst it was encamped at Bacon's Bridge, shortly before the close of the war – we went afterwards to Dorchester, & marched backwards & forwards until the British went into Charleston.
