I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[Transcribers Note: Both Bobby Gilmer Moss and J.D. Lewis in their respective rosters of South Carolina patriots attribute this claim to <u>Samuel Mayfield S16930</u>. I question this attribution because the services described do not match those claimed by that veteran in his pension application. Consequently, I have elected to treat this as a claim made by someone other than that veteran. My attribution, however, may well be in error. I'll let the researchers using this transcript make their own determination.]
