I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Senate and House of Representatives of the State of South Carolina – The Petition of John Moffett Colonel under the command of Genl. Thomas Sumter Sheweth that your Petitioner did in the year one thousand Seven hundred and eighty-three Purchase certain Indents from William Stephenson Senior & William Stephenson Junior, James Wilson & Adjutant Richard Whitaker of Colonel Hill's Regiment of Horse General Sumter's Brigade – And that the Commissioner of Accounts for Revolutionary Claims did Certify to the amount of said Claims to the amount of three Hundred and forty-five Pounds four Shillings Sterling your petitioner further states that the said Certificates were lost or mislaid and that he has never found said papers until the Present year.

Your Petitioner therefore Prays your Honorable body to Grant him Such Relief as in your wisdom you may think is right And your Petitioner will ever Pray November 10th, 1825
