Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the President and other members of the Senate of South Carolina

The petition of James Bone of the district of Williamsburgh respectfully Sheweth – that your petitioner served as a soldier from the commencement of the revolution to the close of that eventful period – as the accompanying certificates will fully make appear – first under Daniel Horry at the memorable attack on Sullivan's Island in June 1776 [June 28, 1776]. In 1778 & 1779 under Captain John Alston [sic, John Allston], a considerable part of the time commanded by General Pulaski. In the 1780 after the fall of Charleston [Charleston South Carolina fell to the British on May 12, 1780] joined General Marion [Francis Marion] and served under different officers, until the close of the War and was engaged in several different skirmishes, at Jacksonborough, on the lines of Charleston, at Stono [Stono Ferry, June 20, 1779] - in the fork of Black River [Tearcoat Swamp, October 25, 1780] surprising a large party of Tories – here received a slight wound by a buckshot – again at the lower bridge [Black River Bridge, March 14, 1781] opposing Colonel Watson [Lt. Col. John Watson Tadwell-Watson] – again at Wambau [Wambaw Bridge, February 24, 1782] when the heroic Major James [John James] particularly distinguished himself, and last at Tidimous oldfield [Tidyman's Plantation, February 25, 1782].

Your petitioner further begs leave to state that, in common with the inhabitants generally, he thought the Country so far crippled by the unprecedented struggle that no compensation could be expected for services rendered, he never took a discharge excepting from one officer, which having received little attention was soon lost or mislaid –

Your petitioner further respectfully states that while his health and strength of body continued he was determined not to be chargeable to the public – but for 5 or 6 years past, weakness and infirmity have reduced him to extreme poverty –

Your petitioner further states that he is at this time between sixty-five and seventy years of age, and his companion the mother of many children is nearly of the same age, and more infirm than himself. He therefore hopes that your Honorable body will take his case into your consideration and grant him such relief as in your Wisdom may seem just, and your petitioner as in duty bound will pray. 15th of November 1825


