[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the House of Representatives of the State of South Carolina The humble petition of Thomas McCants [sic] shews to your Honorable body that during the revolutionary war he was a soldier in the service of the State of South Carolina that he was unable to procure certificates to prove his services by any of the officers under whom he served as he believes they are all dead, but that your petitioner would state that he served a tour at Orangeburg was at the taking of the Congaree Fort [Fort Granby]² was in Charleston and its vicinage for about five or six months on duty the only proof which he is able to furnish is the certificate of George Short [sic, George Straight] & David Neely who were fellow soldiers with him and for whose veracity the representatives of this district can vouch.

Your petitioner would humbly hope that your Honorable body will now in his old age grant him the bounty of his country to support him he would not have asked this small pittance though in Justice he might it [undeciphered word] that time the destroyer of all things has taken from him youth & strength and left in their place old age & poverty in the gratitude of his country he has full confidence & throws himself upon their liberality with a full assurance that they will do that which is right and your petitioner as in duty bound will pray.

The humble petition of Thomas McCants shews to your Honorable body That during the revolutionary war he was a soldier in the service of the State of South Carolina That he is unable to procure certificates to prove his service by any of the officers under whom he served as he believes they are all dead, but that your petitioner would state that he served a tour at Orangeburg - was at the taking of the Congaree Fort, Was in Charleston and its vicinage for about five or six months on duty. The only proof which he is unable to furnish is the certificates of George Straight & David Neely who were fellow soldiers with him and for whose veracity the representatives of this District can vouch.

Your petitioner would humbly hope that your Honorable body would now in his old age grant him the bounty of his country to support him. He would not have asked this small pittance though in Justice he might claim it but that time the destroyer of all things has taken from him youth & strength and left in their place old age & poverty. In the gratitude of his country he has full confidence and throws himself upon their liberality with a full assurance that they will do that which is right and your petitioner are ever in duty bound to pray

George Strait [sic] came before me and made oath that during the revolutionary war he was in Camp at Orangeburg at which he saw and knew Thomas McCants as a soldier in the same detachment, who were ordered out to served three months from the district of Chester &c.

That he does not recollect the officers who were commanding but he thinks Colonel Lacey [Edward Lacey] was the Colonel of the detachment from Chester Sworn to and subscribed

Thomas McCants came before me and made oath that he was in the camp during the war of the revolution at the taking of the Congaree Fort – at which time and place he knew David Neely as a soldier in the detachment then under the command of Colonel Lacey – That he knew said Neely to go from home frequently in detachments of militia but was never in the service with him but the once as he recollects, but this deponent knew said Neely to be in service at Orangeburg, as he was in the detachment who went to relieve the detachment in which said Neely was –

This deponent further states that he knew said Neely to lose two horses during the war which this deponent thinks and believes were taken from him by the Tories. That the horses he thinks at time were worth one hundred dollars. This deponent further states that said Neely is an old man and in very indigent circumstances and worthy [of] the Bounty of his country Sworn to and subscribed

did know Thomas McCance in the Revolutionary war and that he did Serve in said war as a Soldier and fought bravely for the freedom of his Country, and that said McCance was a prisoner at the time of Huck's defeat⁵ which was on the 12th July 1780, and he this deponent doth well believe that said McCance was under the command of Captain John McClure [sic, then Major John McClure] who fell at the battle of the Hanging Rock,⁶ and that he the deponent doth further depose that he did himself then command as Captain and afterwards, Rose to the Command of Colonel in said War.
