Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Know all men by these presents that I Newel McConnel Late of the State of South Carolina now of the State of Georgia and County of Wilkes Yeoman Reposing of trust in the Honesty and Fidelity of Robert Neel of the County of Wilkes and State of Georgia Yeoman Do constitute make and Appoint him the Said Robert Neel my lawful attorney for the purpose of Taking or Receiving of What Ever kind of Writing May be Given by the Auditor General of the State of South Carolina for Debts Due to Me from the said State Whether it Be Distinguished By the name of An Indent or by Any other name or wheresoever Lodged Either in the Auditor Office or Elsewhere and Also for my Use and in my name to Use all lawful means for Getting the Same and the Interest Due upon it in the same manner as if I myself were present and in my name and for my use to Trade off the said Interest thereby Ratifying and confirming All that said Neel Shall in my Name agreeable to power invested in him by these writings do In Witness whereof I have hereunto Set my hand this 15<sup>th</sup> day of February A.D. 1786
