Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 7: Printed form of Indent No. 339 Book M dated October 1, 1784 "delivered to Mr. John Willson² late a Lieutenant in Myddelton's [Charles C. Myddelton's] Regiment Sumpter's [Thomas Sumter's] Brigade State Troops this our INDENTED CERTIFICATE, for the Sum of Seventy pounds ten shillings Sterling Being amount pay and bounty due him for Services in that Regiment together with Interest thereon from the 1st April 1782 2 date hereof Agreeable to Resolution of General Assembly of the 11th March last."]

² Lt. John Wilson [sic] is listed in the Payroll of Lt. Col. Charles Myddelton as being due $\frac{1}{2}$ a grown and $\frac{1}{2}$ a small Negro slave taken from Tories. Such horrendous pay was known as Sumter's Wages. When an inadequate number of such slaves were confiscated from the Tories, pay in equivalent currency was authorized by the South Carolina General assembly. Wilson was deemed a supernumerary in that Regiment as per **B398**.
