The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected; for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1



This day Andrew Crawford personally appeared before me and being solemnly sworn saith that being in the public Service of said State under the command of Colonel Andrew Pickens did on or about the 10th of February last lose a riding Bridle and also on the 12th of May last lost a wearing hat while in the public Service of said State under the Command of said Colonel Andrew Pickens and that he the said Andrew Crawford hath received no satisfaction – Neither in whole nor in part for the same. And further this deponent saith not. (That his Head lost in the Battle at Stono the 20th June 1779)

I do hereby authorize & empower William Foster to draw & receive for my use the Indent or Indents and the Interest due thereon, for Services done by my Husband, Andrew Crawford, who was taken prisoner by the Tories near General Pickens' & carried to the Indians & by them put to Death, his Service was mostly as a private on foot in Captain Joseph Calhoun's Company of Militia – Some before the Reduction of Charleston [Charleston South Carolina fell to the British on May 12, 1780] & some since and I believe some Service with his wagon & team for the Service of this State. – Agreeable to returns made by Colonel Robert Anderson into the Auditor's Office.

Given under my hand this 14th day of April 1787
