I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

We do Sartify [certify] that John bettes of burk county [Burke County, NC or Ga.?]² did list [enlist] him Self in to the State brigad [brigade] of South Carolina [probably the State Troops recruited by Thomas Sumter in 1781 to serve under his command for ten months] for the tirm [term] of tin months [ten months] for which we have just caus [cause] to believ [believe] that the sd. bettis Sarved [served] his time—he did not return home until the other Solders [soldiers] did That went with him given under our hands this 18 of November 1790
