Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable Speaker of the House of Representatives of the State of South Carolina The Petition of David Evans poor Industrious young man belonging to the Pee Dee Regiment of Militia

Humbly Sheweth

That your Petitioner from the Commencement of the Present War did on Occasions exert himself in defense of his Country, But had the Misfortune in the 1st [?]² day of September 1780, Under the Command of General Marion [Francis Marion] in an Action against a party of Tories commanded by Major Ford to have his Thigh Broke which Renders him Incapable of getting a livelihood. Therefore we the subscribers Inhabitants of said Regiment Pray your Honors will take so Zealous a Citizen for his Country under your Consideration, & Grant him such Relief as you may Judge he merits by his asserted [?] Conduct.

Thus will Ever pray.

Personally appeared before us David Evans who being duly sworn Deposeth that he doth at this present time & did previous to the 1st of January 1775 – reside in the State of South Carolina & was wounded in the Defense thereof, and was, & is a Friend of the American Cause – and is not possessed of Land nor able to follow the Employment which he used to do before he was so wounded.

Given under our hand and seal this 25th day of May 1793
