Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Whereas I Mary Williams widow of the late Deceased James Williams Do authorize& impower John Hunter Esquire to Draw from the treasury the within mentioned Indent for Publick account Due to the said James Williams Deceased & his Receipt shall be your Discharge.

Given under my hand this 19th September 1785

I Do Certify that the above Mrs. Mary Williams widow of the aforesaid Colonel James Williams Did Sign the above order before me this 19<sup>th</sup> September 1785 Certified by me S/ Charles Nixson, JP

[p 9: claim by the estate of Col. James Williams for provisions [flour and sundries] amounting to £60.10.1 Sterling. At the bottom of the claim, in very faint handwriting, is the following: *"The Auditor is requested to examine Gen. Williamson's* [Andrew Williamson's] Accot. under whom Col. Williams acted in 1779 & to ascertain what payment he rec'd -- & remark respecting Mr. Rutledge [illegible] in 5000 Dollars" [this is a reference to \$5,000 SC Governor in exile gave Col Williams in Hillsborough NC sometime in September of 1780 to enable Williams to recruit men to join him in his attempt to track down and bring to battle the forces under British Major Patrick Ferguson. Williams, with others, eventually caught up with Ferguson and his forces at Kings Mountain SC and defeated them on October 7, 1780. Williams was mortally wounded in that Battle and died the next day. Because of his death at Kings Mountain, no accounting for the \$5,000 has been found to date, but Williams did successfully recruit around 190 men to join him in his march to Kings Mountain. Doubtless some or all that money was used to pay bounties to some or all those men.]

"Also the sum of 5000 Dollars paid him by Govr. Rutledge

At Hillsborough 16 Sept. 1780 in Currency

Genl. Williamson's Acct. were carefully examined & do not find any money charged to Col. Jas. Williams."

[p 11: claim by the estate of Col. James Williams for provisions and sundries provided in October 1779 including 150 gallons of whiskey at 4 shillings a gallon; 1,000 weight of Corn; 600 weight of Flower [flour] and another entry which is illegible.]

[p 12: very faint claim which appears to be in James Williams' own handwriting & to read as follows:]
My own sarvis is from 5 of January 1779 to this Day
At 46 pr. Day
My Wagon & team the same time
My boy & horse to Wat [wait] on me the same time at 40/ Day
Thare is [indecipherable] of [indecipherable] on My books against
The publick that Will fall in [indecipherable] the above

[pp 13-14: appears to be an accounting by Col. James Williams of various provisions from Genl. Andrew Williamson in March and June of 1779 and received by Capt. James Moore; p. 14 bears the following in James Williams' handwriting:

Rec'd of Capt. Jas More [James Moore] by paying an order to My [illegibly faint word] of Mine I say rec'd per me August  $1^{st}$  1779 £2920 18/

To an order give to Mr. Thomas Burk on Mr. Jas. More for 2029.17.3

[In the handwriting I think of Col. Robert Anderson appears the following:] As Colo. Williams is Dead his Attestation to this Account Cannot be had but from Sundry Informations it Appears he furnished the Quantity of Flower & I Cannot find out that he Rec'd Any pay but the Credit Given

N. B. James Moore the Commissary is also Dead—Col. Williams' Hair [heir?] when I took this Acct. promised to Search Mr. Moore's Books & if any thing Appeared on the Books they were to bring a Certificate thereof from the Executors which they have not Done.

[p 15: receipts given by officers for provisions provided by Col. Williams: 1 from John Winn dated March 12<sup>th</sup> 1779 for 6 bushels of corn and fodder; and the other for from John McCullogh dated April 18<sup>th</sup> 1779 for three barrels of flour.]

[p 17: receipt dated April 30, 1779 for 86 lbs of [indecipherable] and a peck of salt provided by Williams to Capt. John Davis for his troops.]

The State of South Carolina

To the Honorable the Speaker and other Members of the House of Representatives of this State

The petition of Col. James Williams of the Newberry Dist. for himself and the other heirs of Col. James Williams Decd.

Sheweth:

That his father James Williams in the year 1776 was elected Colonel and served in the Cherokee expedition, that from that time untill his death at the battle of Kings Mountain he continued in the active service of the state. That he was in the battle of Stono, at the siege of Savannah, in the battles of Musgroves' Mills, and that of Kings Mountain in which he was shott in ? of the advancing parties ascending the mountain and fell near to Col. Ferguson.

That for the whole of his services he never rec'd any compensation (so far as your petitioner is informed).

That your Petitioner for himself and the other heirs of Col. James Williams, is desirous that these facts should be inquired into and if found to be true that then that such compensation may be rendered as the state in its wisdom may think proper.

Wherefore your Petitioner prays that this claim may be investigated and that payment for the same may be made to your Petitioner and the other heirs of Col. James Williams Dec'd.

And your Petitioner will pray.

I Hugh Oneall do hereby certify that I knew Col. James Williams, that I recollect distinctly his service as Colonel in the Cherokee expedition in 1776, that from that time to his death at Kings Mountain he was constantly engaged as a Colonel in the service of this State, that he commanded the troops who went from the section of country in which I was raised to the battle of Stono, the siege of Savannah, the battles of Musgroves Mills and of Kings Mountain. Robert Stark Esq., Col. Samuel Hammond & Thomas Taylor are referred to by the Petitioner for the proof of Col. James Williams Revolutionary Services.

Resolved --- that the Heirs of Col. James Williams who was killed at the battle of Kings Mountain have leave to take the examination in writing of Col. Thomas Taylor, Robert Stark, Esq., Col. Samuel Hammond and Hugh Oneal aged & infirm persons to be read in evidence before this House or its committee in any future investigation of their claims against the State and that Col. James [looks like "Grady"] Col. Wm Preston and Col John G. Brown or either of them be appointed commissioners to take said examinations

Resolution appointing Commissioners to take the examination of certain witnesses. Dec. 18, 1829

Resolved that the House do agree to the Resolution --- to Senate for consideration By action of the House. S/R. Anderson, CHR Senate Dec. 18, 1829

The Joint Committee of both branches of this Legislature to whom was referred the examination of the Claims of Col.
