Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Senate & House of Representatives –

The Humble petition of Edward Prince who has resided in this State about sixty-two years that he is now in the Seventy Eighth year of his age. That during the Revolutionary War he Served a Tour of duty against the Indians under Lieutenant Dodd & that he was drafted to Serve another Tour under Colonel Brandon at the time the British landed at Charles [sic, Charleston?] – He also Served a Tour of duty under Colonel William Fair [William Farr] – also Served another under the said Colonel William Fair at Orangeburg – and during the revolutionary War He your petitioner was generally active in behalf of his Country against the Common Enemy of the Country the British, Indians & Tories, that your Petitioner was repeatedly called on & did Serve as Nurse for the Sick & wounded at the Blockhouses – That your petitioner is now old & very infirm & unable to perform manual labor – that his family is all left him and he is now Poor & has but a small portion of property – and no means of a Support but by his own labor – that your petitioner prays your Honorable body to take your petitioner's Case into Consideration & grant such Relief as you in your Wisdom may deem best – & your petitioner will ever pray –
