Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Speaker and members of the House of Representatives of the State of South Carolina

The petition of Celia Blizard respectfully Sheweth that her husband John Blizard was a revolutionary Soldier & about the year 1779 or 80 he left her prepared to join the American Army and served as he told her a certain time in defense of his country and then came home on furlough told her he had been taken prisoner by the enemy and again retaken by the Americans – Stayed at home the time of his furlough and then left her (with two small children) to go back to camps to serve his country. Shortly after he left home he died in camps – She is now entirely helpless about eighty years of age without any home or subsistence of her own her entire estate consist of one old bed and light furniture. She therefore prays your honours would take her case in consideration and grant her such relief as you deem proper.
