Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The Petition of Solomon Bobo praying for a Pension, was acted on by the last legislature, a Report made by the Committee on Pensions Recommending that he should be placed on the Pension list, and confirmed by the Senate; sent to the House of Representatives for Concurrence was acted on by that House, Concurred in and Ordered for Consideration on tomorrow. The Legislature having contrary to Expectations dissolved on adjournment 2 or 3 Days Earlier than was anticipated, and did so adjourn, the said Report was not Acted upon;

The same proceedings were head on the Petition of Stephen Neale, and left in the same Unfinished State; they are both very Dependent; Aged & Infirm, were Reputed as Faithful Soldiers of the Revolution, of good Characters – which they still retain
